Known issues or agreements _____

This contract is made for the protection of both Buyer and Seller. Seller will not make exceptions to this contract once signed so please read carefully and fully understand all conditions of this contract. Any known issues with this puppy and/or any agreements made between Buyer and Seller will be listed above prior to the signing of this contract. This contract cannot be transferred to a new owner other than the Buyer named and signed this contract.

Health Guarantee

Seller offers a **72-hour Puppy Health Guarantee** which only covers an untreatable life threatening illness. Puppy must be seen by a licensed Veterinarian within 72 hrs. of transfer of this puppy for a health check. Buyer must acquire proof of a vet check within 72 hrs. and keep a copy with this contract. Contract is void and Seller is released from any further obligations to Buyer if not vet checked or cannot provide proof of vet check within this time. If the veterinarian diagnoses this puppy with an untreatable life threatening illness, a copy of the diagnosis (must include: Vets name and signature, date, address, phone number, puppy's name, and birthdate) must be sent to the Seller immediately for review. A replacement puppy will be offered (when available) of equal value or greater value if the difference is paid by Buyer. If a replacement puppy needs to be shipped, the Buyer and Seller will each pay one half of the shipping cost.

Seller offers a **two-year Genetic Health Guarantee** from the date of purchase of this puppy with an untreatable life threatening congenital (present at birth) illness which includes heart, liver, kidney, and brain ONLY. Veterinary and lab tests must be done at Buyer's expense, and results must be sent to Seller immediately. A replacement puppy will be offered (when available) once all Vet documentation has been received and verifies a congenital condition. If a replacement puppy needs to be shipped, Buyer and Seller will each pay one half of the shipping cost. Two-year genetic health guarantee is void if proof of a 72 hr. puppy health check cannot be provided to Seller.

Terms of Sale

- All puppies are kept by Seller until they are 9 weeks old or longer if needed. No exceptions will be made for early pickup.
- Seller will provide Buyer with a complete health record. This puppy has been vaccinated at least twice, and dewormed every two weeks starting at two weeks of age. All puppies receive a complete Vet exam at Fort Branch Veterinary Hospital before leaving Seller.
- Seller does not guarantee against internal or external parasites, and viral or bacterial infections. Seller has no control as to what puppy is exposed to after leaving Sellers care.
- Seller will not be held liable for any illnesses for which the dog should be vaccinated against past 48 hours after puppy leaves Sellers care. Buyer agrees to avoid this puppy's exposure to public places, parks, and other dogs until puppy has had all age appropriate vaccines.
- Seller does not guarantee against under or overbites, hernias, patellar luxation, hip or elbow dysplasia, cherry eye, stenotic nares, eye infections, corneal ulcers, cataracts, entropion, epiphora, dry eye, progressive retinal atrophy, intervertebral disk disease, allergies, open fontanel, heatstroke or hypoglycemia as these are common breed issues that can be treated, managed, and/or can correct on their own with age.
- Buyer agrees that this puppy will be an inside only dog as part of their family and not left outside or tied up. If there is any evidence of abuse or neglect to this dog, Seller has the right to retain immediate possession of the dog at no expense to the Seller, and no refund of any kind to the Buyer.
- Seller will not refund money for any reason. Only a replacement puppy will be given if necessary by the terms of this contract.
- Buyer agrees they have done their research of the breed and common health issues and is committed to the life of this puppy.
- Buyer has the right to request a full vet exam with requested tests or concerns checked and receive a vet report prior to the puppy leaving Seller. If an additional Vet exam is requested, this will only be done at the Buyers expense.
- Seller is not responsible for any medical costs after puppy has left Sellers care. It is the responsibility of the Buyer to keep puppy current on all vaccines, deworming's, and recommended Veterinary care to insure the health of the puppy.
- There is no guarantee as to the size, quality, color, or temperament of the puppy at maturity.
- A puppy will not be sold to a breeder if Seller does not feel the puppy is of breeding and/or show quality. Seller makes no guarantees as to the quality of a puppy or the ability to breed and or be shown as an adult. Seller has the right to refuse any puppy to be sold for breeding/showing at any time for any reason.
- Seller offers a take back policy for the life of this puppy. NO REFUNDS are given, but if Buyer cannot keep the puppy for any reason and have not been able to rehome the puppy, Buyer agrees to return the puppy to Seller before placing in an animal shelter or rescue.

This contract is legal and may be enforced by legal means. Should the Seller or Buyer need to seek legal action for violations of this contract, the Buyer will assume any and all attorney and court costs and any lawsuits must be brought before the Gibson County Court in Indiana.
